# ENDOWMENT CHALLENGE PROGRAM

The Legislative Committee of the Wyoming Library Association is proceeding with a course of action involving preparation of legislation for an endowment challenge program for Wyoming's public libraries. The WLA Executive Board approved the committee's idea at WLA/MPLA conference in October and encouraged members to proceed. All county libraries have been contacted in an informal poll to determine if there is support for the legislation. Happily, all of the counties are supportive. With this consensus, the Committee was confident in continuing with the legislative process.

The program is modeled after the Wyoming Community College Endowment Challenge Program that is currently in place. The state treasurer would set up a fund to match endowment gifts received by the public libraries. Each county library would have their own \$1 million dollar account, administered through their library foundations. A match would be paid at the time a library foundation had raised \$10,000 or more. This would DOUBLE the amount of all endowment gifts, and each library would have five years to raise funds.

WLA and the Legislative Committee are concerned that Wyoming's libraries have experienced revenue shortfalls for many years. Some libraries have been forced to reduce service hours, staff and book budgets because of inadequate funding. Wyoming Statute establishes county libraries as the only governance system possible in the state. This endowment challenge would give county libraries an unprecedented opportunity to work with the State. The endowment would allow the State to invest at a higher level in long term, enduring organizations that assist ALL Wyoming citizens....Libraries. There is great potential that this would give more financial security to smaller, struggling libraries.

The economic climate and the opinions of the Joint Appropriations Committee will determine whether the endowment challenge program will be put before the Legislature this year or next. Librarians, trustees, foundations and legislators need to keep in mind that improvements in libraries promote education, life-long learning, literacy and economic vitality. They hold an inestimable value for the future of Wyoming.

It isn't too early to think about all of the great people you work with every day and how one, or maybe more than one, deserve an award this year. Nominations are due in June, so you have plenty of time to think about it.

On a related note, I encourage people to apply for the Nora Van Burgh Development Grant. Each year the WLA executive board budgets \$1000 to fund this wonderful grant. This program was established to provide funding assistance to those who wish to enhance their effectiveness as library employees through additional educational experience. Non-degreed library employees, a majority of the WLA membership, are particularly encouraged to apply.
